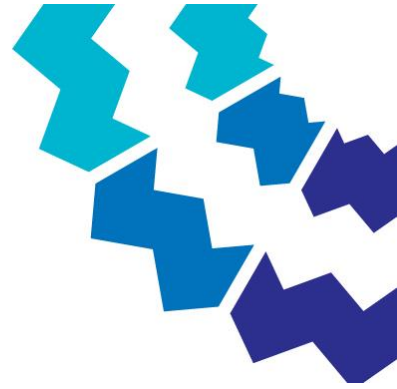




Berkshire Vision Privacy Policy

How Berkshire Vision uses your information

This policy tells you what to expect when Berkshire Vision collects personal information. It applies to information we collect about:

- Visitors to our website
- Email marketing
- Social media
- Supporters and donors
- Our fundraising promise
- Other information

Visitors to our website

When you visit www.berkshirevision.org.uk we use Google Analytics to collect standard internet log information and details of visitor behaviour patterns. We do this to track interest on specific pages, see how the site is being used and look at how we can make improvements to the site. The information is only processed in a way that doesn't identify anyone. We do not make, and do not allow Google to make, any attempts to find out the identities of those visiting the Berkshire Vision website. If we do ever try and link our cookies and tracking information, we will explain why and what we intend to do with it.

Use of cookies by Berkshire Vision

What is a cookie? A cookie is a small data file of letters and numbers that is downloaded from our website by your computer. We use these cookies to help provide you with a good experience when browsing our website and they also allow us to improve our site. Cookies are not programs and don't collect any data from your computer.

How we use cookies

Our website uses 'analytical' cookies which recognise and count the number of visitors to our website and also allow us to see how visitors move around the site when they are using it. This helps us to improve the way our website works, for example by ensuring that users are finding what they are looking for easily.

The information that we gather through these cookies is completely anonymous and visitors to our website cannot be identified personally.

Third party and social media site cookies

Please note that our other online partners and social network sites, such as Facebook and Twitter, may also use cookies, over which we have no control. Please check the website of the relevant third party for information on their cookie policy.

Controlling and deleting cookies on your computer

All browsers allow you to manage which cookies you accept reject and delete via controls found under the 'Preferences' or 'Tools' menu. Please note however that if you disable our cookies you may not be able to access certain services or facilities on our websites and your use of our site may be restricted.

WordPress

The Berkshire Vision website is built with WordPress, it's hosted by 2Oi via Kreatif Digital Design Agency who are contracted as a data processor for Berkshire Vision. Our website uses standard WordPress services to collect anonymous information about users' activity on the site, for example the number of users viewing pages on the site and how long they spend on a given page. We do this to monitor and report on the effectiveness of the site and help us improve it.

Email marketing

We use a third-party provider, Mailchimp to deliver our monthly email newsletter. We gather statistics around email opening and clicks using industry standard technologies to help us monitor and improve our email newsletter.

We send our email newsletter so that you can find out more about our work, our fundraising and how you can support us. We only send our email newsletter to supporters who opted in to receive email marketing from Berkshire Vision or a business email address where the work of Berkshire Vision may be of interest to you. You may have subscribed to our email newsletter via an online form on our website or Facebook, by verbally opting in when on a visit to Berkshire Vision or when in conversation with one of our staff or via a third party for example when choosing to support Berkshire Vision via a donation website i.e. JustGiving or Localgiving. We'll never sell or share your details.

Instead outline the general details of your request and a member of staff will respond or direct you to someone who can help. Your message will not be shared with any other organisations.

People who email us

Any email sent to us, including attachments, may be monitored and used by us for reasons of security and monitoring compliance with office policy. Email monitoring and blocking software can apply if an email triggers one of our built-in safeguards.

Emails you send us may be stored so we have a record of communication between Berkshire Vision and yourself and can manage that relationship as best we can.

Our promises to you

- To ask, listen to and act on your wishes so that you value your relationship with and communications from Berkshire Vision and if you don't wish for such a relationship then all you need to do is say. We will not put undue pressure on you to support us. If we get things wrong, we will say sorry and put things right.
- To communicate with you according to your wishes. We will make it clear and easy for you to choose how to hear from us. You are free to request a copy of the information we have about you at any time. To do this, please get in touch by emailing info@berkshirevision.org.uk
- To protect your information. Any details you share with us will be used by Berkshire Vision only for our own purposes. We will never give, sell or rent your information to other organisations for their marketing purposes.

Collecting your information and protecting your privacy

In the process of making a donation, signing up to our communications and/or making an enquiry to Berkshire Vision, you may have provided us with personal information. This may include your name and address, your contact details, your birthday or age.

When you supply information to us, we are legally obliged by the General Data Protection Regulation 2018 to ensure that the information you have provided is only used for the purpose for which it was supplied, and to ensure that the data is kept securely.
